Re: Job Creation Analysis

To Whom It May Concern:

Baker Tilly Advisory Group, LP ("Baker Tilly"), is pleased to assist Bohn Valley Holdings 1, LLC (the "JCE"), with the preparation of this report. This report will summarize current, to-date EB-5 eligible job creation for the Anasu Resort Phase 1A Project (the "Project").

Assumptions

The Project consists of Phase 1A, that includes the development and thereafter operation of a 40-key hotel, a residence club, two (2) resort villa models, two (2) estate home models, approximately 48,000 square feet of retail space, an entry barn, farm buildings, an emergency response center, a sales center and the development of 39 finished resort lots, 62 finished wine lots, 63 finished villa lots, site landscaping and infrastructure for all listed components. The Project is located on an approximate 16,000-acre property in the Guenoc Valley in Lake County, California.

The original I-526E economic analysis, dated September 2023, utilized 2020 RIMS II multipliers for Lake, Mendocino, Sonoma, and Napa Counties in California. For the purposes of this report, the same multipliers will be used to generate job creation.

The expenditures utilized in this report were taken from the Consolidated Balance Sheet prepared by Spott, Lucey & Wall, Inc. for the Lake County Entities: Bohn Vally Inc, Butts Creek Inc, and Guenoc Vally Inc.

Construction employment is based upon actual hard construction costs. Construction will last over two years; therefore, direct job impacts for purposes of this report have been used to calculate job creation under USCIS rules.

EB-5 eligible soft costs such as architectural and engineering costs are also used per USCIS guidelines for job creation.
